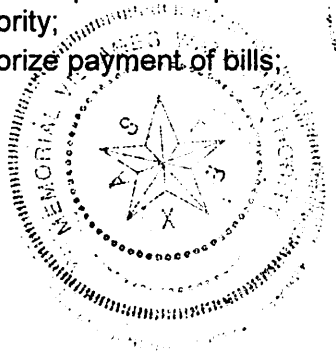

In accordance with Chapter 551, Texas Government Code, and Section 49.063, Texas Water Code, both as amended, take notice that the Board of Supervisors of Memorial Villages Water Authority will meet in regular session, open to the public, at the Water Authority's Building, 8955 Gaylord, Houston, Texas, 77024, a location within the Authority, at 7:00 p.m. on Tuesday, November 6, 2018. At such meeting, the Board will consider the following:

6. Status Report on the 2016-2017 Sanitary Sewer Rehabilitation Project, consideration of Pay Estimate #17, and take any necessary action;
7. Status report on LAS Project;
8. Renew Authority insurance, to wit: (expires October 1, 2018): General Liability, Auto Liability, Commercial Umbrella Liability, Supervisor and Officers Liability, Worker's Compensation, Errors and Omissions, Boiler and Machinery, Real and Personal Property, Automobile Physical Damage and Mobile Equipment;
9. Renew Authority insurance for 2019, to wit: Major Medical, Life and Accidental Death and Dismemberment, Dental, Long Term Disability and Supplemental Life;
10. Discuss and set employee participation amounts for Major Medical, Life and Accidental Death and Dismemberment, Dental, Long Term Disability and Supplemental Life;
11. Manager's Report including; monthly water samples, Wastewater Treatment Facility's monthly discharge compliance, Tax Recap, Investment Report on the Authority's investments, monthly Identity Theft Compliance Report and approval thereof and any other matters concerning business of the Authority;
12. Authorize payment of bills;
